John Madden, *BEc (ANU)*, *BA*, *DipEd*, *PhD (Tas)*, has been a Professor in the Centre of Policy Studies (CoPS) since 2006 (A/Prof 2002-06; Deputy Director, 2004-2012). Prior to joining CoPS in 2002, Madden was Director of the Centre for Regional Economic Analysis at the University of Tasmania for over a decade. Madden was a Visiting Fellow at the University of Melbourne in 1987 and a Scientific Fellow at Erasmus University, Rotterdam, for six months in 1992/93. During 2001 and 2002 Madden was a member of a Stanford University study team on fiscal federalism in a global environment.

Professor Madden was President of the Pacific Regional Science Conference Organisation in 2011-2012. From 2002 to 2007, he was one of six elected Councillors-at-Large on the International Council of the Regional Science Association (RSAI). He is a former President of the Australian and New Zealand Section of RSAI (1999-2000) and of the Tasmanian branch of the Economic Society of Australia (1986-88). He is a Regional Editor (Asia-Pacific) of *Regional Science Policy and Practice*.

Madden has undertaken around 135 grant-supported and commissioned studies. These include economic studies of: national competition policy, the goods and services tax, the safety net review, redistribution of federal government grants to the Australian states, numerous major investment projects (e.g. the Very Fast Train, North West Shelf Gas, Basslink) and megaevents (e.g. the Sydney Olympics and the FIFA World Cup). He has undertaken studies for various Australian Government departments, all Australian State Governments, the Malaysian Government, the Florida Legislature, and many private organisations.

Professor Madden's primary research activity is in the area of computable general equilibrium (CGE) modelling. Madden is the author of FEDERAL, which was one of the first large-scale spatial CGE models. His applied modelling work is in the areas of fiscal federalism, regional development, major investment projects, tourism, mega-events, energy, the environment, natural resources, labour markets, transport, industry productivity, and microeconomic reform. With James Giesecke he is co-author of the chapter on regional CGE modelling in Elsevier's *Handbook of Computable General Equilibrium Modeling*. His current research projects include dynamic fiscal CGE modelling, linked stochastic disease transition-CGE models, small region CGE modelling with commuting, and fiscal federalism.
