SUMMARY OF EXPERTISE

Dr. Nhi Tran is a Senior Research Fellow at the Centre of Policy Studies, Victoria University. Her expertise and research interest focus on policy analysis using computer general equilibrium (CGE) models. Examples of her work include: the construction of dynamic CGE models with extensive fiscal detail for the Vietnamese Ministry of Finance, the Malaysian Ministry of Finance and the Italian Ministry of Economy and Finance; the construction of labour market forecasting models for Vietnam and Oman; and the construction of a multiregional dynamic model of Australia with migration detail. The models were used to analyse a wide range of economic policies, including tax reform, fiscal stimulus package, trade liberalisation, climate change adaptation, rice land designation policy, labour market forecasts and immigration policies. She is an active member of the GTAP community, contributing the Vietnamese, Singapore and Malaysian databases to the GTAP 9.0 database.
